### **1. BILL SUMMARY**

**Legislation Title:** AN ORDINANCE relating to the 2016 Budget; amending Ordinance 124927, which adopted the 2016 Budget; changing appropriations to various departments and budget control levels due to changes in City employment compensation; and ratifying and confirming certain prior acts; all by a 3/4 vote of the City Council.

**Summary and background of the Legislation:** This legislation increases budget appropriation authority for cost increases because of Council Bill 118807 passed by City Council authorizing the execution of a collective bargaining agreement between the City of Seattle and the International Brotherhood of Electrical Workers Local No. 77 Information Technology Professionals Unit.

The collective bargaining agreement provides a retroactive annual wage increase for 2015 and 2016 to all full-time, regular part-time and temporary Informational Technology Professional B and C positions employed by the City.
