CITY OF SEATTLE 1 ORDINANCE 125209 2 COUNCIL BILL 18851 3 4 AN ORDINANCE authorizing the levy of regular property taxes by The City of Seattle for 5 collection in 2017, representing an increase above the regular property taxes levied for 6 collection in 2016; and ratifying and confirming certain prior acts. 7 8 WHEREAS, to increase regular property taxes, RCW 84.55.120, as approved by the voters of the 9 State of Washington in "Referendum 47" on November 4, 1997, requires the City to enact 10 a separate ordinance indicating the change in taxes from the previous year in terms of 11 percentage and total amount; and 12 WHEREAS, The City of Seattle proposes to make its regular property tax levy for collection in 13 2017 in the amount reflected in the companion ordinance to this Bill, which is commonly 14 known as the "Long Property Tax Ordinance"; and 15 WHEREAS, the Long Property Tax Ordinance for 2017 authorizes an increase above the amount 16 of regular property taxes levied for collection in 2016; and 17 WHEREAS, pursuant to RCW 84.55.120, after proper notice was given, the City Council held 18 public hearings on October 5, 2016 and October 25, 2016, to consider The City of 19 Seattle's 2017 budget and the regular property tax levy to support it; and 20 WHEREAS, notice of the City Council's consideration of this ordinance has been provided in the 21 usual manner for other proposed City ordinances; NOW, THEREFORE, 22 BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS: 23 Section 1. Regular property taxes for collection in 2017 are authorized in the amount 24 reflected in the ordinance introduced as Council Bill 118837. Not including increases resulting 25 from the addition of new construction, construction of wind turbine facilities classified as 26

personal property, improvements to property, and any increase in the value of state-assessed property, the regular property tax levy for 2017 collection represents an increase above regular property taxes levied for collection in 2016 (excluding the "refund fund levy" in both instances) of \$24,549,782, which is a 5.82 percent increase. These regular property tax levies for collection in 2016 and 2017 include regular property tax "levy lid lifts" previously approved by the voters of The City of Seattle.

Section 2. Any act pursuant to the authority of this ordinance taken after the passage of this ordinance is hereby ratified and confirmed.
