8 9	WHEREAS, a proposed plat of "Fremont on the Ave" has been submitted for approval to the
10	Seattle Department of Construction and Inspections (SDCI) and given the Permit No.
11	3018511; and
12	WHEREAS, following review and recommendations by the various City departments that have
13	jurisdiction in this matter and a public hearing by the Hearing Examiner of The City of
14	Seattle, the Hearing Examiner approved the preliminary plat of "Fremont on the Ave"
15	subject to certain conditions on January 28, 2016; and
16	WHEREAS, the Director of Transportation and the Director of SDCI have, subject to Council
17	approval, approved the final plat and have reported that the final plat now meets all of the
18	requirements of the State platting law (chapter 58.17 RCW) and of the Seattle Municipal
19	Code (Chapter 23.22), except for the execution of the required certifications by the King
20	County Assessor and the King County Finance Division; and
21	WHEREAS, the Director of Transportation and the Director of SDCI report that the plat of
22	"Fremont on the Ave," a copy of which is in C.F. No. 314239, is now complete and ready
23	for City Council approval; NOW, THEREFORE,
24	BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

- City ordinances that were in effect at the time of preliminary plat approval will also have been satisfied by the subdivider; and
- (c) The public use and interest will be served by the establishment of the plat, and the plat makes appropriate provision for the public health, safety, and general welfare.
- Section 3. The plat of "Fremont on the Ave," a subdivision of portions of the Northeast 1/4 of Southwest 1/4 of Section 18, Township 25 North, Range 4 East, W.M. in King County, Washington, is in all respects approved and the plat confirmed and accepted, subject to certification by the King County Assessor and King County Finance Division, and the City Clerk is hereby authorized and directed to execute a certificate upon the face of such plat attesting to the approval thereof as evidenced by enactment of this ordinance.

1	Section 4. This ordinance shall take effect and be in force 30 days after its approval by
2	the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it
3	shall take effect as provided by Seattle Municipal Code Section 1.04.020.
