**1. BILL SUMMARY**

Legislation Title: A RESOLUTION requesting Congress to allocate funding to adequately address the maintenance needs of the National Park System.

**Summary and background of the Legislation:**

This resolution requests Congress to allocate appropriate funding to address the infrastructure repair backlog at National Parks nationwide. Washington state’s share of that backlog is an estimated \$510 million. Potential funding solutions include: reforming the current system of entrance, recreation, and commercial franchise fees; providing additional federal funding to leverage private dollars for infrastructure repairs; providing increased funding through the federal Highway Trust Fund to support construction and upkeep of park roads, bridges, and tunnels.
