Michael Reichert was appointed President and CEO of Catholic Community Services of Western Washington in 1979 by Archbishop Hunthausen. He is also President and CEO of Catholic Housing Services (a sister corporation). In 2002, he became President and Trustee of the Catholic Charities Foundation of Western Washington.

Mr. Reichert provides leadership to his organization's limited liability corporations and partnerships for many low-income housing projects. He served for three years as a gubernatorial-appointed Commissioner of the Washington State Housing Finance Commission, and as an appointed Commissioner of the Washington State Gambling Commission.

In his work at Catholic Community Services and Catholic Housing Services, Mr. Reichert is responsible for combined budgets exceeding \$170 million, and managing more than 3,300 employees. In 2015, CCS/CHS served more than 111,000 unduplicated clients.

Throughout his career, Michael Reichert has also served as a Board Member and Treasurer at the WaHeLut Indian School in Olympia, Washington; a Senior Fellow with the Wildflowers Institute in San Francisco; a member of the United States China Education Institute (USCEI); Council Member for the Franks Landing Indian Community, in Olympia, Washington; Board Member at the United Indians of All Tribes Foundation in Seattle; the founding Chair for the Catholic Charities C.A.R.E Committee, a Diversity and Empowerment Program; Chairperson, National Catholic Housing Commission; Chairperson, Founding Father of the Low Income Housing Institute; Chairperson, National Indian and Native American Employment & Training Coalition; Chairperson, McCauley Institute, Washington D.C.; Development Consultant for the North Central Montana Coalition; Board Member and Treasurer, Puyallup International Incorporated; Board Member, Catholic Charities USA, Washington D.C.; Board Member, Northwest Harvest; Board Member, Intercommunity Housing; Vice-Chairperson, Greater Maple Valley Council and Chief Financial Officer for the Puyallup Tribe of Indians.

The Seattle Indian Services Commission (SISC) is a public corporation as defined in City of Seattle Ordinance 103387 and was chartered in 1972 to: Provide effective, comprehensive, and coordinated planning services, activities, and programs that will meet the unique needs of the many Native American residents of Seattle who are scattered throughout the city.

The commission was originally formed in 1972 to obtain a Seattle Model City Program grant of \$600,000 to purchase a building for use as a center for Indian service organizations.
