AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment thereof.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$13,055,060.84 on Summit mechanical warrants numbered 4002781755 – 4002784162 plus manual or cancellation issues for claims, E-Payables of \$63,713.07 on Summit 9000026915 – 9000026976 and Electronic Financial Transactions (EFT) in the amount of \$18,483,377.20 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. Payment of the sum of \$43,961,881.56 on City General Salary Fund mechanical warrants numbered 51269069 – 51269743 plus manual warrants, agencies warrants, and direct deposits numbered 70001 – 82564 representing Gross Payrolls for payroll ending date February 7, 2017 as detailed in the Payroll Summary Report for claims against the City which were audited by the Auditing Committee and reported by said committee to the City Council February 16, 2017 consistent with appropriations heretofore made for such purpose from the appropriate Funds, is hereby approved.
