1. BILL SUMMARY

- **a.** Legislation Title: AN ORDINANCE relating to the proposed Mercy Housing Northwest project for development of low-income housing and non-residential space in Building 9 at Sand Point near Warren G. Magnuson Park; authorizing the Housing Director to grant a temporary construction easement and permanent utility and driveway easements over City-owned property South of Building 9 to benefit the Building 9 property; and authorizing related documents and actions.
- **b.** Summary and background of the Legislation: Ordinance 118963 authorized the City to assume ownership of certain land at the former Naval Station Puget Sound at Sand Point. The Office of Housing has jurisdiction over several parcels.

The State of Washington owns the former barracks known as "Building 9." In 2014 the State selected Mercy Housing Northwest (MHNW) to receive title to and redevelop this property to provide for affordable housing and a range of other public benefits. In addition to the property, the state provided funding for the redevelopment. The project has also received an award from the Seattle Office of Housing, with combined sources of public funding totaling in excess of \$20 million. The project will ultimately provide approximately 148 units of housing affordable to low-income individuals and families as well as non-residential elements providing health care and preschool affordable to low-income families, with construction scheduled to begin in July 2017.

Access to and from the property requires vehicles and pedestrians to travel over roadways on property under the Office of Housing's jurisdiction. Temporary construction and permanent emergency and driveway easements are necessary to the redevelopment and ongoing operations of the Building 9 project. The Office of Housing has determined that these easements offer the only practicable access options necessary to obtain the public benefits to be provided by the Building 9 Project.
