1. BILL SUMMARY

- a. **Legislation Title:** A RESOLUTION expressing The City of Seattle's commitment to being a more age-friendly city under the criteria established by the World Health Organization and the AARP Network of Age-Friendly Communities.

- b. **Summary and background of the Legislation:** As the population of older adults in the City of Seattle increases, this resolution commits the City to making greater consideration of age-friendly programs and projects. Specifically, the resolution asks City departments to develop goals and indicators of success centered around the World Health Organization's Eight Domains of Livability. In addition, the resolution lays out department-specific early action items for 2017 to:
 - Seattle Department of Transportation: Assess sidewalks with the involvement of seniors, improve the pedestrian environment, and incorporate age-friendly criteria into the Pedestrian Master Plan Implementation Plan for 2018-2022.
 - Human Services Department: Expand transportation options for seniors, increase usage of the Regional Reduced Fare Permit with King County Metro, improve senior services provided or facilitated by the City by implementing a "no wrong door" structure.
 - Human Services Department and Department of Parks and Recreation: Involve seniors in the development and engagement process for new capital investments and increase participation in senior-focused recreation programs.
 - Human Services Department and Office of Housing: Create a housing action plan to assess senior housing needs, target low-income seniors to increase enrollment in the Utility Discount Program and the senior property tax exemption program, increase access to weatherization services and home repair programs, and evaluate feasibility of senior home-sharing options.

In addition to early actions, the resolution also commits to a community equity forum focused on the needs to lesbian, gay, bisexual and transgender elders.

The City will consider suggestions for age-friendly improvements in the 2018 budget and will report on the progress of the initial three-year plan to the Human Services and Public Health Committee, or other appropriate City Council committee, regularly, and will present a final report in 2021.

The early action items outlined in the Resolution have existing funding in the current budget. Specifically, the 2017 Adopted Budget includes \$400,000 of funding for a sidewalk condition assessment by SDOT, which will support the early action items involving sidewalk review outlined above.

f. Please describe any perceived implication for the principles of the Race and Social Justice Initiative. Does this legislation impact vulnerable or historically disadvantaged communities?

Racial disparities in health, well-being and economic security are compounded by age. Among older adults, communities of color are more likely to report being in poorer health than whites and are less likely to reap the benefits of increased life expectancy. Increasing racial equity is one of the four major goals of Age-Friendly Seattle. Among the strategies for achieving this goal is to integrate an age-friendly lens into the City's equity initiatives, such as its Race and Social Justice Initiative.

g. If this legislation includes a new initiative or a major programmatic expansion: What are the specific long-term and measurable goal(s) of the program? How will this legislation help achieve the program's desired goal(s).

The four goal areas associated with Age-Friendly Seattle are:

- Increase social participation;
- Decrease displacement;
- Increase racial equity; and
- Increase awareness of the opportunities and challenges of an aging population.
