1. BILL SUMMARY

- **a.** Legislation Title: AN ORDINANCE amending Ordinance 125248 to modify the effective date of certain sections of that ordinance.
- **b. Summary and background of the Legislation:** On February 2, 2017 Seattle City Council passed Ordinance 125248, approving updates to environmentally critical area (ECA) regulations. Ordinance 125248 amended several provisions of the City's Shoreline Master Program, which are subject to review by the Washington State Department of Ecology (DOE).

It is appropriate that DOE review those amendments simultaneously with future updates to Seattle's Shoreline Management Program. Council expects the Seattle Department of Construction and Inspections to propose updates to the Shoreline Management Program in a future bill for Council consideration and possible action.

This legislation would amend the effective date of certain sections of Ordinance 125248 to allow for consolidated DOE review of Shoreline Master Program amendments without postponing the effective date of the remaining sections.
