1. BILL SUMMARY

a. **Legislation Title:** AN ORDINANCE amending Ordinance 125207, which adopted the 2017 Budget, creating and revising budget control levels, modifying positions, and changing appropriations to various departments and budget control levels; all by a 3/4 vote of the City Council.

b. Summary and background of the Legislation:

Council Bill 118969 establishes a comprehensive, independent and sustained approach to civilian and community oversight of the Seattle Police Department (SPD), creating a new Chapter 3.29 in the Seattle Municipal Code.

This companion legislation amends Ordinance 125207 by establishing a budget control level (BCL) code, position authority and appropriations for the 2017 fiscal year for the Office of Inspector General for Public Safety (OIG). This legislation further amends Ordinance 125207 by changing the name and description of the Office of Professional Accountability to the Office of Police Accountability. Council Bill 118969 also requires that the Office of the Community Police Commission (CPC) budget shall be appropriated in a Budget Control Level that is independent of any other City department; the BCL code for the Office of the CPC is changed accordingly.

The establishment of the OIG was anticipated in the development of the 2017-2018 biennial budget and funding to support start-up activities was set aside in Finance General Reserves. This legislation transfers the reserved funding to the newly created OIG BCL code and adds position authority for four positions.

On July 27, 2012, the U.S. Department of Justice and the City of Seattle entered into a Settlement Agreement and Memorandum of Understanding (collectively, "Consent Decree") related to ensuring police services are delivered to the people of Seattle in a manner consistent with the Constitution and laws of the United States. The U.S. Department of Justice investigation of SPD was requested by representatives of and advocates for marginalized communities who experienced and/or were concerned about unconstitutional SPD practices. This legislation ensures measures to maintain and build on reforms instituted under the Consent Decree begin to be implemented quickly.
