### 1. BILL SUMMARY

- a. **Legislation Title:** AN ORDINANCE relating to the Department of Parks and Recreation; authorizing the Superintendent of Parks and Recreation to enter into a Project Partnership Agreement (PPA) with the Seattle District United States Army Corps of Engineers for purposes of executing the Alki Coastal Erosion Control Project; and ratifying and confirming certain prior acts.
- **b. Summary and background of the Legislation:** This legislation authorizes the Superintendent of Seattle Parks and Recreation (SPR) to enter into a cost-sharing agreement with the U.S. Army Corps of Engineers (CoE) for the purpose of building a new seawall to replace the existing, badly deteriorated seawall at Emma Schmitz Memorial Overlook Park.

The total project cost is estimated at \$2.9 million. Per the agreement, the CoE will cover 65% of the project costs (\$1.9 million) and the city will cover the remaining 35% (\$1 million). The city's contribution would change only if the current scope of work changed, which is not anticipated. That said, as with any capital project there is a risk of increased costs, and the project budget includes a contingency to cover a certain amount of unforeseen changes.

The project is currently fully funded with contingency through a combination of resources including \$650,000 from the 2008 Parks and Green Spaces Levy, \$150,000 from the Park District, and \$350,000 from REET and the Community Improvement Contribution Fund.

If the Parks and Recreation Superintendent cannot authorize the agreement, the project will not move forward, and the seawall will not be replaced. The seawall already has a high probability of failure, which increases with each year. Failure of the seawall will result in raw sewage spilling into Puget Sound, necessitating emergency repairs and resulting in possible fines that will exceed the cost of proceeding with the project as currently proposed.
