

#### VEHICULAR LIVING WORKGROUP RECOMMENDATIONS

The workgroup met during the months of March and April in a total of five meetings.

Because it was the goal of the workgroup to develop all possible policy solutions, consensus was not required and thus the recommendations lay the groundwork for potential policy and programming advancements.

The Workgroup produced 9 recommendations with two additional addendums.

### RECOMMENDATIONS CONTINUED

Problem Identified	Recommendation Proposed
Incomplete data	Fund research
Unidentifiable vehicular residences	Build informative database to indicate vehicular residences and reduce harmful penalties
Informal parking enforcement	Ensure more formal parking enforcement

### RECOMMENDATIONS CONTINUED

Problem Identified	Recommendation Proposed
Inability to meet vehicular costs	Fund fee mitigation services
Insufficient outreach	Expand outreach and supportive services
Inadequate healthcare access	Increase healthcare services

## RECOMMENDATIONS CONTINUED

Problem Identified	Recommendation Proposed
Inadequate safe parking	Create a safe parking program
Lack of recreational vehicle parking	Develop recreational vehicular living campgrounds
Missing skills-based programming opportunities	Invest in an auto-mechanic skills training program
