1. BILL SUMMARY

- **a.** Legislation Title: AN ORDINANCE relating to the City Light Department; declaring certain real property rights surplus to the needs of the City Light Department; authorizing the partial release of a City Light easement; and accepting the payment of fair market value for the partial release of easement.
- **b.** Summary and background of the Legislation: This legislation will declare certain real property rights surplus to the needs of the City Light Department and will authorize Seattle City Light to partially release an easement for transmission line purposes in Snohomish County, Washington. The City of Seattle will retain vegetation management rights within the easement area. The City Light Department will receive \$31,000 for the partial release of easement, comprising the fair market value of the easement release and the value of the retained easement rights.

Seattle City Light owns a 150'-155' wide transmission corridor, composed of easements and fee title property, commonly known as the MapleValley to Sno-King 230 kV lines running north/south from Renton to Bothell. The easements for this line were acquired in the late 1920s. One easement was acquired in 1927 from M.C. Carlson ("Carlson"). The Carlson easement was over a large, undefined easement area. This easement lies outside the 150'-155' wide functioning Seattle City Light corridor and immediately east and abutting the corridor. The Carlson easement was partially released in 1994, which released everything but the west 50 feet of the easement.

The Quadrant Corporation is constructing a single family residential development in Snohomish County. The west 50 feet of the Quadrant development parcel is encumbered by the Carlson easement. All other Seattle City Light easements north and south of this 50-foot easement were released in the 1980s and 1990s because they served no useful utility purpose. There are now single family residences on all parcels north and south of the Quadrant development parcel. Quadrant wishes to have the easement released so that it can fully utilize and develop its parcel. The partial release of the remainder of the Carlson easement will not affect Seattle City Light's ability to access, construct, operate, or maintain its existing transmission corridor. Seattle City Light will retain its rights within the Carlson easement to trim or remove trees and manage vegetation that pose a hazard to the transmission lines.
