#### **1. BILL SUMMARY**

**a.** Legislation Title: AN ORDINANCE relating to the Urban Forestry Commission; adding three new members; and amending Sections 3.72.020 and 3.72.030 of the Seattle Municipal Code.

### b. Summary and background of the Legislation:

This legislation adds three positions to the Urban Forestry Commission (Positions 11, 12, and 13). The three new positions would be occupied by an Environmental Justice representative, a Public Health representative, and a Community/Neighborhood representative, to complement the highly technical nature of the Commission and bring additional perspectives. These positions would serve for a renewable three-year term and would contribute to the Commission's diversity.

#### Background:

The Urban Forestry Commission was created in 2009 by Ordinance 123052 to advise the Mayor and City Council concerning the establishment of policy and regulations governing the protection, management and conservation of trees and vegetation in the City of Seattle.

The Commission was last amended in 2014 via Ordinance 124671 creating Position 10, a Get Engaged youth position.

The Urban Forestry Commission is a highly technical advisory body. Adding three positions would complement existing skills/experience and would contribute to the Commission's diversity.
