### **1. BILL SUMMARY**

### a. Legislation Title:

A RESOLUTION calling for additional actions by the City and its partners to advance the vision of the Uptown Urban Design Framework, leverage new investments at Seattle Center to support mobility and promote livability in the Uptown Urban Center as both Uptown and Seattle Center grow, and to update the Seattle Center Century 21 Master Plan.

### b. Summary and background of the Legislation:

Since 2013, the City has been working with the Uptown community to develop and implement the Uptown Urban Design Framework. The framework defines a clear vision for an active and dynamic Uptown and identifies those actions necessary to implement that vision. This resolution voices support for that Urban Design Framework, and identifies next steps in implementing the framework. The resolution also recognizes the ongoing and planned work to support Seattle Center's mission to create exceptional events, experiences and environments that delight and inspire the human spirit to build strong communities.

Specific activities identified in the resolution include:

1. Updating the Seattle Center Century 21 Master Plan;

2. Building on partnerships with the Seattle Center Advisory Commission and Seattle Center Foundation;

3. Taking actions to support affordable housing in Uptown;

4. If outside funding becomes available, preparing a North Downtown Mobility Action Plan;

5. Working with Sound Transit to site a new light rail station in the neighborhood;

6. Updating the Uptown Neighborhood Design Guidelines;

7. Completing a Historic Resources Survey; and

8. Developing new business practices to support vulnerable masonry structures.
