Legislation Title: AN ORDINANCE relating to street and sidewalk use; amending the Street Use Permit Fee Schedule authorized by Section 15.04.074 of the Seattle Municipal Code.

Summary and background of the Legislation: This legislation updates and adjusts street use rates and fees to more closely follow policy goals for project and construction coordination, swift and certain permit enforcement, and mobility. As authorized in SMC 15.04.074, it also advances the goal of full-cost recovery for permitting.

The 2018 estimated revenue assumes that permit volume is consistent with current activity.

The revenue impact of this legislation is as follows:

• \$3.6 million increase due to rate changes;

improve public understanding of costs.

- \$5.12 million increase due to issuance fee changes; and
- \$270,000 decrease due to renewal fee changes.

Under current law, base permit and hourly fees would increase by 2.75 percent effective January 1, 2018. The \$8.45 million revenue impact assumes rate changes are delayed until April 1, 2018 and represents the marginal increase in rates and fees due to this legislation.

Yes. This legislation advances the goal of full cost recovery for permitting activities, reducing the need for use and occupation fee subsidy for permit review, coordination, and inspection.

- b) Is there financial cost or other impacts of not implementing the legislation?

 Not increasing rates and fees will reduce the cost recovery of SDOT's permitting activities, increasing reliance on use and occupation fee subsidies. Experience suggests that regular periodic changes in certain fees help to maintain cost recovery levels and
- c) Does this legislation affect any departments besides the originating department? SDCI collects and bills certain fees for SDOT as part of the building permit process. Other departments that apply for and receive permits, including Seattle Public Utilities and Seattle City Light, will be impacted by these rate and fee increases. Public utilities and other public agencies represent a very small group of major permit applicants and

these rate and fee changes are intended to incentivize more careful permit and plan preparation and better-maintained work sites. Departments that currently have long-term public interest permits, including Parks, will have reduced renewal fees to incentivize more positive uses of the right of way, like street furniture and artwork.
