### Budget Action description:

This budget action reduces GSF support to Finance and Administrative Services (FAS) related to fencing actions for unauthorized encampment clean ups. This budget action does not involve fencing related to Special Emphasis Areas as defined in the FAS Encampment Rule.

This budget action also increases GSF support for the Human Services Department (HSD) by \$500,000 to fund services for unauthorized homeless encampments, including sanitation-related services, portable toilets, and trash removal. These services should not be coordinated with unauthorized encampment removal, or "sweeps," and are intended as a harm reduction strategy.
