**1. BILL SUMMARY**

**Legislation Title:**

AN ORDINANCE conditioning the Seattle Department of Transportation’s 2018 grant applications.

**Summary and background of the Legislation:**

The Seattle Department of Transportation (SDOT) relies on a variety of state, federal, and external funding grants to fund transportation projects in the Capital Improvement Plan. In applying for grants, SDOT is signaling a City commitment to the project, which may have local match requirements or on-going operations and maintenance costs.

As part of the 2017 Budget approval process, Council passed Ordinance 125205, specifying the projects for which SDOT could apply for grants of greater than \$5 million in 2017. Future Council action is required to accept grant funds.

This legislation would authorize SDOT to apply for external grants for specific capital projects identified in the legislation. The legislation is permissive and would allow SDOT to seek grants for any of the projects listed, but does not require that SDOT apply for grants for any specific project. Unless listed in the legislation, SDOT would be prohibited from applying for project grants of more than \$5 million. This ordinance could be amended over the course of 2018 to reflect new grant opportunities or changes to capital priorities.
