AN ORDINANCE relating to land use and zoning; amending Chapter 23.32 of the Seattle Municipal Code at page 150 of the Official Land Use Map to rezone property located at 5911 42nd Avenue Southwest from Single Family 5000 to Lowrise 1, and accepting a Property Use and Development Agreement as a condition of rezone approval. This ordinance would rezone property located at 5911 42nd Avenue SW from Single Family 5000 (SF 5000) to Lowrise 1 (LR1). The property consists of a single parcel of land measuring 18,681 square feet. The applicant proposes to develop three townhouse structures, with a total of six units, parking for 12 vehicles within attached garages and an open space area.
