Grassroots Beginning to Community Pillar

- In the late 1960s, community leaders and student activists were angered over living conditions for the elderly in single room occupancy hotels and dilapidated Chinatown/International District neighborhood
- ID Health Clinic started in 1973 as part of the civil rights movement, with the Asian community demanding equal rights and access to services
- ID Health Clinic initially focused on the needs of isolated and elderly Chinese and Filipino men with no health care
- Arrival of Vietnam War refugees in the 1970s quickly shifted services to accommodate additional languages and all ages
- Today a full-service primary care provider with 8 sites in King County, serving approximately 50 languages a year

ICHS at a Glance 2016

- 28,660 unduplicated patients in 2016; 55% Seattle residents
 - Preliminary 2017 unduplicated patients: 30,578
- 142,062 FQHC visits
- 363,638 total health encounters

- Patient Income Levels
 - 44% 100% FPL and below
 - 74% 200% FPL and below
 - 8% unknown
- 59% Medicaid/CHIP
- 55% of patients in 2016 have language barriers
- 51% accessed dental services
- 20% needed enabling services
- 12% Medicare
- 11% uninsured
- 9% homeless

- 7 sites are Patient Centered Medical and Dental Home through Accreditation Association for Ambulatory Health Care (AAAHC); 8th site new and pending
- Seattle sites

 - Mobile Dental Clinic serving 10 Seattle Schools and community organizations
- Model of Care evolving based on care management, case management and integration approaches

Challenges

- Federal executive and Congressional anti-Affordable Care Act, anti-Medicaid legislation, budget and continuing attacks
 - Community Health Center funding in same boat as CHIP – expired September 31, 2017 and extended only through March after huge advocacy efforts
