COUNCIL BILL 19175

AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment thereof.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$38,942,379.11 on Summit mechanical warrants numbered 4002911897 - 4002915565 plus manual or cancellation issues for claims, E-Payables of \$417,973.64 on Summit 9000030239 – 9000030332 and Electronic Financial Transactions (EFT) in the amount of \$63,701,303.62 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. Payment of the sum of \$44,570,169.63 on City General Salary Fund mechanical warrants numbered 51287966 - 51288618 plus manual warrants, agencies warrants, and direct deposits numbered 10001-22721 representing Gross Payrolls for payroll ending date December 26, 2017 as detailed in the Payroll Summary Report for claims against the City which were audited by the Auditing Committee and reported by said committee to the City Council January 4, 2018 consistent with appropriations heretofore made for such purpose from the appropriate Funds, is hereby approved.
