#### 1. BILL SUMMARY

- 1. **Legislation Title**: AN ORDINANCE relating to Seattle Public Utilities; accepting easements granted to The City of Seattle for installation, operation, and maintenance of a sewer pipe, sewer and drainage infrastructure, underground utility pipelines and related equipment, a public sanitary sewer mainline, a public storm drain mainline, a public storm drain manhole, and access and appurtenances necessary for drainage and wastewater utility purposes at various locations in Seattle; placing the property rights and interests conveyed by the easements under the jurisdiction of Seattle Public Utilities; and ratifying and confirming certain prior acts.
- 2. **Summary and background of the Legislation**: This ordinance would authorize the City of Seattle to accept 10 utility easements and one consent for property acquisitions to meet the requirements of other parties' property developments.

The Seattle Department of Construction and Inspections (DCI) may require certain property developments include storm drainage facilities, sewer facilities, sanitary sewers, access, combined sewers, storm detention and appurtenances necessary for drainage and wastewater utility purposes. Many of the property rights accepted by the City pursuant to this ordinance are for utility installations on private properties required for DCI project approval.

The remaining easements are for King County's North Beach CSO project, which requires Seattle sewer and drainage facilities be moved out of street right-of-way into private property. Those property rights are necessary for construction, maintenance, improvement, and replacement of the relocated facilities.
