Qualifications for the Aging and Disability Service Advisory Council

I would like to be appointed to the Advisory Council on Aging and Disability Services because I have an interest, passion and desire to be involved in eliminating poverty, and fighting for the availability of health care for all, including seniors and people with disabilities.

My experience with seniors includes working as an investigator for the U.S. Department of Education, Office for Civil Rights where I investigated cases alleging age and disability discrimination as well as other areas of discrimination.

My volunteer experience includes being a grass roots volunteer advocate for RESULTS, an anti-poverty organization that has both a domestic and a global program. As a volunteer advocate, my primary activities include meeting with and lobbying members of congress, meeting with congressional aides, writing letters to members of congress, writing letters to the editors, writing op-eds, and attending town hall meetings, all with the objective of trying to influence policy decisions that will bring an end to poverty both domestically and globally. Specific issues include Supplemental Nutrition Assistance Program (SNAP), Medicaid, income and wealth inequality and tax reform as it pertains to spending cuts to health care and the safety-net programs.

With respect to AARP my volunteer experience is similar, i.e., advocating on behalf of seniors to address the challenges of housing, Medicare/Medicaid, hunger, income, isolation and fraud.
