
Western Washington Phase II Municipal Stormwater Permit

National Pollutant Discharge Elimination System and State Waste Discharge General Permit for discharges from Small Municipal Separate Storm Sewers in Western Washington

> State of Washington Department of Ecology Olympia, Washington 98504-7600

In compliance with the provisions of The State of Washington Water Pollution Control Law Chapter 90.48 Revised Code of Washington and The Federal Water Pollution Control Act (The Clean Water Act) Title 33 United States Code, Section 1251 *et seq*.

Until this permit expires, is modified, or revoked, Permittees that have properly obtained coverage under this permit are authorized to discharge to waters of the state in accordance with the special and general conditions which follow.




Low-impact Development

- Low-impact development (LID) is an <u>alternative</u> to sending stormwater runoff directly into waterways like Puget Sound.
- Incorporates natural drainage solutions into development
- Uses strategies that collect and filter rainfall and protect people from pollution and flooding.

failed to meet the 15% permit requirement



barely updated, making only minor changes

made updates to truly 47% improve their code

- Over 50% of Puget Sound municipalities missed the mark
- 8 municipalities went above and beyond ('Green Stars')


Accountability
