


A Community Health Based Response to Homelessness and Opioid Crisis

SERVICES AND PROGRAMS SERVING 75,000 PATIENTS



NEIGHBORCARE HEALTH'S SERVICES FOCUSED ON HEALTH CARE AND HOMELESSNESS

12,000 homeless or recently homeless individuals.

- Developed services across the continuum to specifically address homelessness, with an aim to meet people where they are, supporting transition to and maintaining stable housing:
 - Outreach services on the streets, in encampments
 - Specialized clinics focused on exclusively homeless youth (45thStreet) and adults (Ballard)
 - On site care in supportive housing working with chronically homeless adults transition




NEIGHBORCARE HEALTH'S HOUSING PARTNERSHIPS

The Housing Health Outreach Team partners with supportive housing providers to help chronically homeless adults stay housed, providing on-site care:

Total housing retention at one year or more for those chronically homeless seen through our on-site services is 98%.

We also work with low-income housing providers through nurse visits and community health workers to connect residents with health care and to live more independent and healthy lives:

In a survey of 233 public housing residents: 82% exercise at least once a week; 68% exercise at least three times a week or more.

NEIGHBORCARE'S RESPONSE TO THE OPIOID CRISIS

Neighborcare Health is a leading responder to the opioid crisis in Seattle/King County:

- Buprenorphine/Naltrexone 21 (Drug Addiction Treatment Act -DATA)-waivered providers across our clinics.
- Over 800 new prescriptions for medication-assisted treatment (MAT) between 4/1/17 – 3/31/18. This is a 54% increase over the 500 new prescriptions from prior year.
 - 600+ patients treated with Buprenorphine, increasing every day
 - 180+ patients treated with naltrexone (alcohol, opioid), increasing every day

- Narcan on hand to reverse impacts of opioid overdose.
 - 257 patients treated, rate increasing every day
- Partner with Valley Cities for Medication Assisted Treatment and Community Health (MATCH). To expand access and to help patients maintain stability.
- > 2017 King County estimated need for MAT is in excess of 12,000 patients
