11. Describe five of the more significant matters that you have handled and give the citation if the cases were reported.

I represented the Seattle Housing Authority in *Housing Authority of Seattle v. Anthony D. Silva*, 94 Wn.App. 731 (Wash Ct. App 1999). I was the attorney in both the eviction action and on appeal. Mr. Silva alleged the Authority failed to provide proper notice of eviction and did not satisfy Seattle's just cause eviction ordinance when it terminated his lease. He also alleged the Authority engaged in discrimination by refusing to reasonably accommodate his disability. SHA's actions were upheld on appeal.

As Deputy General Counsel at Seattle School District, I co-designed a training titled "Adult Sexual Misconduct", recognized by the United States' Department of Education as an outstanding training program on identifying sexual misconduct in the workplace. It was important to create a training program that reduced and/or eliminated the number of incidents in which adults were engaging in predatory behavior towards vulnerable children in an educational setting.

I represented Seattle School District in the non-renewal of employment contract hearing of John Cummings, a special education teacher. The Court of Appeals upheld the termination. *John Cummings v. Seattle School District*, 68519-8 (Wash. Ct. App. 2013)

As in-house counsel for Seattle Housing Authority's, I created the Authority's ADA accommodation process for residents and employees. The process played an integral role in making sure that the Authority provided safe housing to all its residents.

In my role as Deputy General Counsel, I represented the Seattle School District in a PERC unit clarification petition under *Seattle Education Association*, *Petitioner v. Seattle School District*, No. 22642-C-09-1412. Seattle Education Association filed a petition for Clarification of Bargaining Unit for forty-one District positions. I successfully argued that most of these long-tenured positions should remain outside of the bargaining unit. This was an important win for the numerous departments affected by this petition.

# 12. If you have had any other experience in the legal profession that you believe enhances your qualifications for serving as a trial judge, briefly describe it here.

As an employment-law attorney and human resources professional for several governmental and non-profit organizations in the Greater Seattle area, I provided advice and counsel on a full range of employment issues with an emphasis on hiring, terminations, employment contracts, preventive counseling, internal investigations, HR policies and practices, workplace disputes, conflict resolution, negotiation, collective bargaining, arbitrations, grievances, training, regulatory compliance, and agency reporting requirements. I have served as an EEO and Title IX officer. I also successfully responded, negotiated, and resolved complaints filed with HUD, EEOC, Seattle's Office of Civil Rights, Seattle-King County's Human Rights Commission, Office of Superintendent of Public Instruction (OSPI), U.S Department of Education, and U.S. Department of Justice.

As in-house attorney for the largest housing authority in Washington State, I provided legal counsel on various legal issues including employment and labor, residential landlord-tenant (public housing and Section 8), fair housing, civil rights, risk management, contracts, insurance-related matters, premises liability, torts, construction, procurement, real estate, and other key legal issues. I oversaw the Authority's 504/American Disability Act procedures and process for several employers. I implemented the Authority's fraud investigation program.

I began my legal career as a public defender. During the six years I worked at The Public Defender Association, I successfully defended hundreds of adults and juveniles charged with felonies and misdemeanors in King County Superior Court, King County District Court, King County Juvenile Court, and Seattle Municipal Court.

13. Describe your experience or interactions, both personally and professionally, with individuals from different racial, ethnic, religious or cultural backgrounds than your own. Please describe efforts you have made in order to promote diversity

in your professional and personal activities and to assure equal access to the law for all individuals.

As a public servant leader, I have a wealth of experience, training, and knowledge in addressing diversity, equity, inclusion, and bias in the educational and work settings. I have direct experience working with individuals from different racial, ethnic, religious or cultural backgrounds as a public defender, attorney and/or human resources administrator for two urban school districts, the largest public housing authority in Washington state, and three non-profit health care organizations.

I currently serve as the District and Municipal Court Judges Association's (DMCJA) representative on the Washington State Minority and Justice Commission.

During the ten years of employment at Seattle School District, I worked with Superintendents who set forth initiatives to address the racial inequities and achievement gap in the district. At the time I worked there, Seattle School District had a student population of approximately 46,000 students who originate from 148 different countries and 7,000 employees. In 2001, I participated in Courageous Conversation on Race, which comprised of district-wide discussions about the impact of race on teaching and learning. Administrators and staff received training to lead "courageous conversations" within the district. The training had us reflect on our own beliefs and actions about equity and ethnicity and how those actions affect others. As a district employee, I participated in The People's Institute Northwest's Undoing Institutional Racism (UIR) workshop held at the district's central office. The Institute's 2-day workshop "helps participants understand what racism is, how it functions, why it persists and how it can be undone." These workshops have been conducted for numerous organizations including the City of Seattle and King County.

In 2004, the District hired a director of equity, race relations, and learning support. During the director's tenure at the District, she created a workshop series that brought speakers to the District to discuss race and equity in the workplace and classroom. She asked me to conduct a panel discussion with other women of color to talk about whether women of color hit the "glass ceiling." I invited two women of color I worked with at the Seattle Housing Authority to join me for this panel discussion.

During the tenure of Seattle School District's superintendent, Dr. Maria Goodloe-Johnson, I was selected to participate in the Superintendent's 18 months Leadership Program. During the program, I was asked to read several books, participate in workshops, and receive training on how to serve as a servant-leader in an environment where achieving diversity and equity in public education has been a constant challenge since the Supreme Court declared in 1954 in the case of *Brown vs. Board of Education* that state laws establishing separate public schools for black and white students to be unconstitutional.

As Executive Director of HR and General Counsel for Tukwila School District, I was responsible for recruiting a teaching staff that could effectively teach a diverse student population of students. Although it is a small urban school district, it is the most diverse

school district in the United States according to the New York Times. Tukwila's 3,000 student and family population speak over 80 different languages. According to the Martinez Foundation whose mission is to improve teacher diversity and the retention of teachers of color in Washington State, Washington state has close to 60,000 teachers, but only 9% of those teachers are teachers of color. Tukwila agreed with the philosophy of Martinez Foundation that students have an equitable learning environment, when a diverse teaching staff teaches them. I collaborated with colleges, universities, and non-profit organizations such as the Martinez Foundation to recruit teachers and student teachers of color as well as to recruit teachers and student teachers who desired to work with a diverse population of students.

The Tukwila School District's Superintendent appointed me to serve on the District's equity committee. The committee members were tasked with the responsibility of drafting and/or revising district policies addressing the issues and/or concerns affecting a diverse student population. I also served as the Superintendent's designee on the City of Tukwila's Equity and Diversity Commission.

As a member of the Loren Miller Bar Association, Delta Sigma Theta Sorority, Inc. and Greater Seattle Chapter of Links, Inc., I recently participated in the following community activities designed to expand the community's knowledge of the criminal justice system, ways to navigate within the legal system, and providing clarification on how the system is equally accessible to citizens:

- 1) For the 2016 Martin Luther King Celebration program held at Garfield High School, I was a panel member for the workshop titled Education 101: The LAW and YOU, your rights as a YOUTH! This workshop was an interactive discussion between lawyers, Black Law Enforcement officials, and members of Delta Sigma Theta Sorority, Inc., Alpha Kappa Alpha Sorority, Inc., Greater Seattle Chapter of Links, Inc, and the NAACP. Audience members were provided information about how to interact with law enforcement and the courts.
- 2) For the 2017 Martin Luther King Celebration program held at Garfield High School, I was a panel member for the workshop titled Black Lives Matter, Back by Popular Demand. The workshop offered a focus on race relations in the city as well as in the country. It featured a diverse panel of members of community advocates, UW Law Students, and lawyers. The panelists and audience members discussed the various social, educational, legal, political and psychological barriers that are challenging citizen's everyday lives. The UW law students shared information from the "Know Your Rights Pamphlets." The panelists also discussed what steps individuals can take to report incidents where they feel they have been targeted unfairly and want to proceed cautiously to report civil violations as well as constructive ways to "Stop the Violence and ways that the community can come together to address the today's issues and concerns regarding race relations. The panelists and audience members also discussed the court system and current cases being litigated in King County Superior Court and in other courts across the country.

# 22. State those qualities that you consider to be most important in a person holding judicial office.

The courts, particularly in a diverse community such as Seattle need to be recognized as institutions that are accessible, impartial, competent, diverse, and preserves the integrity of the criminal justice system. Judges can assure this recognition occurs by being culturally competent. Culturally competent has been defined as individual or organization "having various levels of awareness, knowledge and skill of the others' ability, age, beliefs, ethnicity, experience, gender, gender identity, linguistic background, national origin, race, religion, sexual orientation, and socioeconomic status" of others. When judges are culturally competent they can discern more accurately the programs and/or processes the court is able to institute that will insure meaningful access to the judicial system with competent legal representation, properly trained interpreters, placement of reasonable accommodations, and disseminate information on the availability of community resources such as housing, clothing, and healthcare especially for those facing economic hardships.

# 23. State your reasons for seeking appointment to the municipal court bench. Include those qualities you possess that you list in question 22.

I am seeking the position of Seattle Municipal Judge because I am an experienced judicial officer and attorney who has worked in the education, housing, healthcare sectors and criminal justice system. I am a committed public servant who has experience, training, and knowledge in addressing diversity, equity, and inclusion in organizational settings. I have over 33 years of continued volunteer service with local and national non-profit organizations.

I am proud to be one of the longest serving Judge Pro Tempore in King County District Court as well as having been unanimously selected to serve as Magistrate Judge and Pro-Tem Judge by the elected Seattle Municipal Court judges.

Over the years I have received acknowledgement from citizens who have appeared in front of me and other judges for my work as a judicial officer. In January 2009, then Presiding Judge Barbara Linde received a letter regarding my performance in Small Claim Court on January 5. The author of the letter, a Plaintiff wrote the following: "I want to take this opportunity to express appreciation to Judge Pro Tem Faye Chess Prentice, who presided over my hearing in the Small Claims Court at the Kent Courthouse (case#94-000013) on the afternoon of January 5th. I reluctantly took my case to Small Claims Court but for eight months I have been unable to collect funds I believed were honestly due (sic) to me. Ms. Prentice was very fair and open in hearing my case and in dealing with the Defendant, who at time was somewhat confrontational. I felt she made a clear decision and resolution to the dispute. Because I was in the courtroom for more than two hours before my case was heard, I was able to observe Judge (sic) Prentice work with several cases. She was very sensitive to the needs of each person who appeared before her. I was especially impressed with her extra work with an older couple with disabilities who seemed to be overwhelmed by the proceedings. She served their need in an exceptional way. I know all of you in the judicial system have huge challenges in performing your work. Please share this letter with Judge Prentice as an expression of my appreciation." I was honored to receive an unsolicited acknowledgement of my work as a judge from a member of the public.

In April 2015, while I was serving as a Pro-Tem Judge in Shoreline District Court, the court's computer system experienced an outage. Presiding Judge Donna Tucker acknowledged the staff's appreciation of my "calm demeanor in working with the staff to maintain normal court operations without access to the electronic files." Judge Tucker thanked me for my leadership during a stressful situation with the court staff. I pride myself on being a servant leader in every position I hold. It was wonderful to know that I was such a leader during a very difficult time for the court staff.

Since my arrival at Seattle Municipal Court, I have received the following cards and comment cards from the public:

This was my first exposure to it, and I actually had no idea what the process would involve. Thanks to you, my pre-hearing conference was a real education. What an interesting job you have?"
- "I had the "BEST" judge (F. Chess) today (10/12/2017) at 10:00 a.m. She's compassionate and a wonderful Human being!!! Thank you Judge F Chess!!!"
- "I just wanted to let you know that Judge Faye Chess was incredibility helpful and understanding to the situation in which I managed to obtain a parking ticket! From

someone that is not native to the Seattle area, this kind person is one-of-a kind! I hope you take not her character and make sure to always hold her in hold regard! Thank you"

I am a good steward of court resources. I am respectful of the public, the attorneys, court staff and administrators of their time, opinions, and resources that are extended to move cases though the judicial system. During my career, I have earnestly made every effort at being fair, knowledgeable, reliable, capable, and thorough. I will bring these same attributes to an elected judicial position.






