AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment thereof.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$30,045,099.97 on PeopleSoft 9.2 mechanical warrants numbered 4100038810- 4100041477 plus manual or cancellation issues for claims, E-Payables of \$175,404.87 on PeopleSoft 9.2 9100000490 – 9100000541 and Electronic Financial Transactions (EFT) in the amount of \$21,674,079.19 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2.
