1. BILL SUMMARY

1. Legislation Title: A RESOLUTION superceding and replacing the language in Statement of Legislative Intent, 281-1-B-2, adopted in Resolution 31795.

Summary and background of the Legislation: Every year the City Council (Council) reviews and approves the City of Seattle's budget, including Statements of Legislative Intent (SLIs) which request the Executive to develop policies, strategies, programs, and information to assist future Council decisions. The Council adopts these SLIs by Resolution; and the 2018 SLIs were adopted by Resolution 31795. Subsequent to the adoption of Resolution 31795, Councilmember O'Brien, who sponsored SLI 281-1-B-2 and the Executive met and clarified the information that would be needed to compare the wages of employees who work for non-profit human service providers and City employees at the Human Services Department who are required to have comparable experience and skills and perform comparable job duties. The Executive has agreed to an amended scope of work that can be done within existing resources;
