CITY OF SEATTLE 1 ORDINANCE 125596 2 COUNCIL BILL 3 4 AN ORDINANCE amending Ordinance 125561 to rename the plat of "Madrona Glen" to 5 "Madrona Glen Estates". 6 7 8 WHEREAS, the Seattle City Council passed Ordinance 125561 approving and confirming the 9 plat of "Madrona Glen" in portions of the Southeast 1/2, Southwest 1/4, Section 25 10 Township 24 North, Range 03 East, W.M. in King County, Washington; and 11 WHEREAS, the King County Assessor informed Robert Hardy, Managing Member, that the 12 name "Madrona Glen" has already been used as a plat and the plat identified in 13 Ordinance 125561 could not be recorded as currently named; and 14 WHEREAS, the City of Seattle now seeks to amend the plat name to "Madrona Glen Estates"; 15 NOW, THEREFORE, 16 BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS: 17 Section 1. Ordinance 125561 is amended to rename the plat of "Madrona Glen" as 18 "Madrona Glen Estates." 19 20 21
