1. BILL SUMMARY

1. Legislation Title:

AN ORDINANCE relating to historic preservation; imposing controls upon the Century 21 Coliseum/KeyArena, a landmark designated by the Landmarks Preservation Board under Chapter 25.12 of the Seattle Municipal Code, and adding it to the Table of Historical Landmarks contained in Chapter 25.32 of the Seattle Municipal Code.

2. Summary and background of the Legislation:

The attached legislation acknowledges the designation of the Century 21 Coliseum/Key Arena as a historic landmark by the Landmarks Preservation Board, imposes controls, grants incentives, and adds the Century 21 Coliseum/KeyArena to the Table of Historical Landmarks contained in SMC Chapter 25.32. The legislation does not have a financial impact.

The Century 21 Coliseum/KeyArena was built in 1962. The property is located in the Uptown Neighborhood (Lower Queen Anne). A Controls and Incentives Agreement has been signed by the owner and has been approved by the Landmarks Preservation Board. The controls in the agreement apply to a portion of the site (as delineated in Attachment A), and the exterior of the Century 21 Coliseum/KeyArena building, but do not apply to any in-kind maintenance or repairs of the designated features.
