1. BILL SUMMARY		

- 1. **Legislation Title:** AN ORDINANCE vacating the alley in Block 22, Brooklyn Addition and additional adjacent right-of-way, and the alley in Block 23, Brooklyn Addition, on the petition of the University of Washington (Clerk File 310162 and Clerk File 310163).
- 2. **Summary and background of the Legislation:** This Council Bill completes the process for vacating the alley in Block 22, Brooklyn Addition and additional adjacent right-of-way, and the alley in Block 23, Brooklyn Addition.

The Petition sought the vacation to maximize development efficiency, to create density in the urban center with additional housing in the West Campus area, to enhance pedestrian connections with wider sidewalks and connections through each site, and to create development flexibility for public open spaces in the Elm Plaza as well as sidewalk and median enhancements.
