1. BILL SUMMARY

1. Legislation Title: AN ORDINANCE relating to land use and zoning; amending Section 23.41.010 of the Seattle Municipal Code to approve the 2018 South Lake Union Neighborhood Design Guidelines.

2. Summary and background of the Legislation:

The ordinance would amend the South Lake Union Design Guidelines to guide future development reflecting the changing character of the South Lake Union Urban Center, provide guidance for new building types resulting from the 2013 rezone of South Lake Union, and to formalize design concepts and principles in the South Lake Union Urban Design Framework.

The current South Lake Union Design Guidelines were initially adopted in 2005 prior to the rapid redevelopment of the neighborhood and its emergence as a major regional jobs center. The guidelines were revised in 2013 to bring them into alignment with new citywide design guidelines adopted that year.

Yes; this legislation amends Title 23 of the Seattle Municipal Code and will require that the City Council hold a public hearing prior to approving the legislation.

This legislation will affect all properties in the South Lake Union Urban Center if they are proposing a redevelopment subject to the City's Design Review Program.

f. Please describe any perceived implication for the principles of the Race and Social Justice Initiative. Does this legislation impact vulnerable or historically disadvantaged communities?

The guidelines resulted from community engagement processes that involved a diversity of stakeholder groups. In general, these design guidelines do not directly address RSJ issues. However, both sets of guidelines are intended to support a safe and healthy environment for all.

g. If this legislation includes a new initiative or a major programmatic expansion: What are the specific long-term and measurable goal(s) of the program? How will this legislation help achieve the program's desired goal(s).

Adoption of this legislation will result in an update to the South Lake Union Design Guidelines. This is not a new initiative or programmatic expansion.
