## 1. BILL SUMMARY

## 1. Legislation Title:

AN ORDINANCE relating to the City Light Department; amending Section 21.49.086 of the Seattle Municipal Code to create Net Wholesale Revenue targets for 2019 and 2020 consistent with those assumed in the City Light 2019-2024 Strategic Plan approved by the City Council via Resolution 31819.

2. Summary and background of the Legislation:

This ordinance sets Net Wholesale Revenue (NWR) targets used by City Light for developing its 2019 and 2020 budgets and sets the Net Wholesale Revenue to be used in the Rate Stabilization Account mechanism established in ordinance 123260. These Net Wholesale Revenue targets are consistent with targets set in City Light's 2019-2024 Strategic Plan, adopted by City Council on July 9, 2018 via resolution 31819.

Monthly Spreads have been updated to reflect City Light's current power portfolio and wholesale market prices.
