## 1. BILL SUMMARY

## 1. Legislation Title:

AN ORDINANCE relating to the City Light Department ("City Light"); amending Ordinance 125493, which amended the 2018 Budget (Ordinance 125475), including the 2018-2023 Capital Improvement Program (CIP); changing appropriations within City Light's Light Fund; revising project allocations for certain capital projects in the CIP; and ratifying and confirming certain prior acts.

# 2. Summary and background of the Legislation:

City Light has identified the need for \$17.4 million in incremental spending authority to support the Advanced Metering Initiative (AMI) capital project, increasing its total project cost from \$84.1 million to \$101.5 million. These increases to the original budget were caused by several items, including: higher-than-expected growth in the service area, which added costs for meter purchases and installments; the addition of sales tax on meter purchases; and the addition of repair costs for meter bases. Please see Attachment A for details on the increases.

City Light will absorb these increases in the existing 2018 Adopted Budget by using expected underspend in some areas, and by deferring some work for several projects. Please see Attachment B for a list of budget items that will be reduced to accommodate the AMI increase.
