1. BILL SUMMARY

Legislation Title: A RESOLUTION amending and adopting the Policies and Procedures that govern the Reuse and Disposal of real property owned by The City of Seattle not subject to the City Light Department jurisdiction; updating certain portions of the procedures related to property reuse and disposal for affordable housing; and adding provisions regarding the use of proceeds from surplus property disposal.

Summary and background of the Legislation: The proposed legislation makes a number of changes to the City’s Policies and Procedures governing the reuse and disposition of surplus city properties, including the following:

- States intent to prioritize available City property for use as affordable housing, including mixed-use development. This priority will be reviewed in 2023;
- Directs the Office of Housing to assist City departments with available properties to assess such properties for suitability as affordable housing and includes criteria to be used in conducting such assessments;
- Unless otherwise directed by ordinance, 80% of net proceeds from disposition of surplus City property – not intended for development of affordable housing are to be deposited into the Low-Income Housing Fund to be used for development of affordable housing and/or the Equitable Development Fund to be used for capacity building for non-profit organizations developing affordable housing.
- The Office of Housing will include in the Annual Investment Report information on City surplus properties, if any, that were disposed of in the prior year for development as affordable housing. Information to be included in this report includes but is not limited to: The number of surplus properties disposed of for development of affordable housing; the number of planned or developed units for each property; other facilities planned or developed along with the affordable housing, such as child care or health care facilities, commercial spaces, etc., and information that supports inclusion of such facilities to meet existing community needs; the name of the organization selected to develop each property; and the population to be served by each proposed project.
