1. BILL SUMMARY

1. Legislation Title:

AN ORDINANCE relating to the City Light Department; authorizing the General Manager and Chief Executive Officer of City Light to execute an agreement with the City of Bothell for relocation of approximately 0.87 mile of existing Fiber Cable 157 along SR 522 from aerial to underground as part of the City of Bothell's SR 522 Stage 3 Improvement Project, including the execution of other agreements or amendments necessary or convenient for the completion of the joint utility trench.

2. Summary and background of the Legislation:

This legislation authorizes a Memorandum of Agreement between the City of Bothell (Bothell) and Seattle City Light (SCL). Bothell is requiring all utilities to underground their aerial facilities as part of the City of Bothell's SR 522 Stage 3 Improvement Project. This project impacts about 0.87 mile of existing SCL's Fiber Cable (FC) 157 along SR 522 of a 10-mile line. By participating in the Joint Utility Trench Agreement will benefit by sharing the cost with other utilities.

Bothell's SR 522 Stage 3 Improvement Project requires that Puget Sound Energy's (PSE) poles located in the right of way be removed. City Light's FC 157 communication path between North Substation and Bothell Substation is currently attached to PSE poles within the City of Bothell and the boundary of this project. As a participant in Bothell's Joint Utility Trench Agreement SCL's fiber cable would be undergrounded along with other utilities (Comcast, Frontier, Verizon, Zayo, PSE, University of Washington) that currently attach to the poles. This joint utility agreement authorizes City Light's participation in the relocation from aerial to underground. City Light is required to pay for project costs for relocations, and the estimated cost for City Light's portion of the project is \$282,087.

- b. Does the legislation have other financial impacts to the City of Seattle that are not reflected in the above, including direct or indirect, short-term or long-term costs? This agreement allows City Light to pay a portion of the cost of the trench and conduit installation. Installation of the fiber cable itself would still be completed by City Light personnel. This project will be completed using existing programmed funding from master project MC-CL-YD9307.
- c. Is there financial cost or other impacts of *not* implementing the legislation?

By not implementing the legislation, City Light would either need to find another aerial path around this section of SR 522 or abandon a10 mile fiber communication path. It is unknown at this point whether another path is available and what the cost would be to bypass this section of SR 522. While the redundancy in City Light's communication system can still provide communication with our Bothell Substation, it is better to have this fiber path restored.
