9	Section 1. Payment of the sum of \$19,275,015.17 on Summit mechanical warrants
10	numbered 4100087493 – 4100091415 plus manual or cancellation issues for claims, E- Payables
11	of \$464,185.97 on Summit 9100001404 – 9100001460 and Electronic Financial Transactions
12	(EFT) in the amount of \$32,213,940.71 are presented for ratification by the City Council per
13	Chapter RCW 42.24.180.
14	Section 2. That any act consistent with the authority and prior to the effective date of this
15	ordinance is hereby ratified and confirmed.
