1. BILL SUMMARY

- 1. **Legislation Title**: A RESOLUTION relating to the Seattle Department of Parks and Recreation; authorizing the Superintendent of Parks and Recreation to act as the authorized representative/agent on behalf of Seattle Parks and Recreation and to legally bind Seattle Parks and Recreation with respect to the Project(s) below for which the City seeks grant funding assistance managed through the Recreation and Conservation Office.
- 2. **Summary and background of the Legislation**: This proposed legislation authorizes the Seattle Department of Parks and Recreation (DPR) to submit grant applications to the State of Washington Recreation and Conservation Office (RCO) for state funding assistance for the projects and amounts listed in the table below. This resolution is required as part of the formal RCO grant application process. Improvements funded by the RCO grant and City or other match sources are listed in the table below.

| Lowman Beach Park Restoration This project will remove approximately 130 lineal feet of a failing vertical concrete seawall and recreate a natural beach with a foreshore and backshore. Removal of the seawall will continue the restoration efforts that were undertaken on the south half of the park where the seawall was removed and the natural beach was restored. This area has seen a return of the natural coastal processes; the beach has expanded and large wood has accumulated. | North Rainier Landbanked Site Park Development This project will develop the open space DPR acquired between 2011 and 2016. The design will incorporate accessibility in compliance with the ADA as well as DPR's intent to create access to open space in areas of high urban density. Impervious surfacing will be limited to 15% or less, excluding trail and circulation surfaces. The park will contain elements that are inviting to people of all ages. Any play elements installed will be appropriate for toddlers, older children and children of all abilities with high play value to increase activation of this area beyond summer months. The design team will investigate creating a complementary design to the upcoming SEED senior housing development, while keeping a unique identity and experience. Design elements may include the incorporation of gathering spaces for lunch and picnicking. Efforts will be made to consider crime prevention through environmental design to activate spaces and discourage negative activity. DPR applies for RCO grants each year and has garnered a strong success rate in securing additional funding for planned capital projects. In 2018, DPR will complete twelve (12) RCO applications total for a total of \$5,540,323 in the following RCO grant categories:

The RCO grants require a local match and will fund only projects that are included in an adopted plan. The recommended projects meet both criteria, as they are either included in the DPR 2017 Parks and Open Space Plan, the DPR 2016-2021 Capital Improvement Program and/or the Seattle Park District Major Maintenance Plan. DPR's required matching funds for the projects are appropriated in DPR's 2016-2021 Capital Improvement Program.

RCO will announce the grant award recommendations in November 2018, but the actual grant awards will not be contracted until 2019. RCO funding will support currently unfunded project elements.

Approval of the proposed resolution will allow DPR to apply for \$5,540,323 in grant funding from RCO.

c. Is there financial cost or other impacts of *not* implementing the legislation?

DPR would not be eligible to apply for RCO grant funding in the 2018 cycle and would forego up to \$5,540,323 in potential project funding. The scope of these projects would have to be reduced or another fund source would need to be identified to accommodate the loss of the anticipated grant funding.

Anticipated Revenue/Reimbursement Resulting from this Legislation:

This legislation authorizes DPR to submit applications for grant funding to RCO during their 2018 grant cycle. If full funding for all grant applications is approved, after the State budget is adopted in 2019, RCO would execute 2-year contracts (2019-2021) with DPR for each project. The grant funding is reimbursable and DPR would receive the following revenues in 2021, at the completion of each project:

Yes. Six of the twelve applications submitted are for projects that are located in diverse communities, some with a large percentage of residents living below the poverty line, and some in communities that are underserved by open green space. The South Park project especially addresses community concerns about racial and health inequities. All the projects serve communities beyond their immediate vicinity and completion of these projects will ensure that the parks are open and accessible to all.
