8	Section 1. Payment of the sum of \$17,494,481.53 on PeopleSoft 9.2 mechanical warrants
9	numbered 4100097423 – 4100099730 plus manual or cancellation issues for claims, E-Payables
10	of \$57,093.33 on PeopleSoft 9.2 9100001561 – 9100001599 and Electronic Financial
11	Transactions (EFT) in the amount of \$91,621,666.84 are presented for ratification by the City
12	Council per Chapter RCW 42.24.180.
13	Section 2. Payment of the sum of \$47,202,923.50 on City General Salary Fund
14	mechanical warrants numbered 51302000 – 51302865 plus manual warrants, agencies warrants,
15	and direct deposits numbered 370001 – 372745 representing Gross Payrolls for payroll ending
16	date September 4, 2018 as detailed in the Payroll Summary Report for claims against the City
