#### **Clean-up Activities: Seattle Parks and Recreation**

- Funding provided to the department in 2018 Adopted Budget.
  - Includes \$1 million of Commercial Parking Tax (CPT) funds from SDOT and \$300,000 in General Fund.
  - Includes one-time funding of \$704,500 provided for equipment purchases (\$500,000 of CPT funds and \$204,500 in General Fund).
- Covers a 13 member crew who support the Navigation Team work.

  - o 2 Truck Drivers
  - 2 Construction Equipment Operators
  - $\circ$  1 Radio Dispatcher

#### **Clean-up Activities: Seattle Parks and Recreation**

#### 2018 Results:

- 179 clean ups supported through September
  - 47 on Park properties (26%)
  - 42 on WSDOT properties (24%)
  - 90 on SDOT properties (50%)
- 100% had needles and toxic materials
- 873 tons of garbage removed

The Encampment Trash program reduces trash in the Seattle right-of-way in approximately 10 neighborhoods at a time resulting from unauthorized homeless encampment. This program distributes purple bags for weekly trash collection from unauthorized homeless encampments. This program also includes need-based on-call collection services.	\$143,291	\$75,996	\$219,287
The Litter Abatement program currently addresses increased trash in the Seattle right-of-way in approximately 10 neighborhoods that are disproportionately affected by the presence of unauthorized homeless encampments by contracting with private, third-party vendors for litter collection and cleaning.	\$168,255	\$260,213	\$428,468
The Sharps Collection program removes used sharps (needles) disposed of on public property citywide by providing on-demand sharps removal and by maintaining City-owned sharps disposal boxes.	\$394,094	\$34,392	\$428,486

The growth requested in the 2019 Proposed Budget reflects inflation, evolving service levels to meet community needs, and in some cases the pilots required more resources than originally budgeted.

The RV Remediation pilot removes RVs that are illegally parked in the Seattle right-of-way or that are illegally parked on property owned by the Seattle Department of Parks and Recreation. This program does this by leading a collaborative effort including: The Seattle Police Department, the Seattle Department of Transportation, Finance and Administration Services, and the Seattle Department of Parks and Recreation.	\$0*	\$219,287	\$219,287	
This pilot in 2019 and 2020 will maintain the current 2018 service levels, which allows for SPU to service six locations throughout Seattle every month. SPU assumed six locations including: - 1 site in each of the: North, East, and West precinct jurisdictions (three sites total) - 1 site in either the South or Southwest Precincts jurisdictions, - 1 site on property owned by the Seattle Department of Parks and Recreation, and - 1 site on an as-needed basis as determined by the pilot team.				
However, as the pilot team reviews potential locations for remediation, any locations that pose a significant risk to health and public safety is prioritized over the base locations assumed above.				
2019 Proposed Budget request maintains the 2018 service levels as well as some slight increases				
for inflation. The 2019 Proposed Budget request is almost entirely for professional service				
contracts with private vendors that will clean up trash from the right-of-way and that will help				
remove any structurally unsound RVs that are left in the public right-of-way.				

\* The 2018 Adopted Budget is \$0 for this project. Historically, a smaller body of work related to illegally parked RVs would be included in the Illegal Dumping program. However, since this is a new pilot that has expanded service levels, SPU is separating the budget and costs going forward.
