Legislation Title: A RESOLUTION supporting Washington Initiative Measure 1639 and urging Seattle voters to vote "Yes" on Initiative 1639 on the November 6, 2018, general election ballot.

The initiative would implement new firearm safety measures, including requiring enhanced background checks, waiting periods, and increased age requirements for semiautomatic assault rifles and secure gun storage for all firearms.
