### **1. BILL SUMMARY**

- 1. Legislation Title: AN ORDINANCE relating to street and sidewalk use; amending the Street Use Permit Fee Schedule authorized by Section 15.04.074 of the Seattle Municipal Code; removing street vacation fees from the Seattle Municipal Code in conformity with the new Street Use Permit Fee Schedule; and amending Section 15.62.030 of the Seattle Municipal Code.
- 2. Summary and background of the Legislation: This legislation updates and adjusts street use rates and fees to more closely follow policy goals for project and construction coordination, swift and certain permit enforcement, and mobility. Permits that provide public benefit (block party permits, flower planters, etc.) will remain low or no-cost permits. Permits with greater impacts (blocking travel lanes, sidewalks, bus lanes, and work in urban villages and center, etc.) will pay more. This will incentivize permitees to minimize the impact to mobility when planning construction activities. As authorized in SMC 15.04.074, it also advances the goal of full cost recovery for permitting. In addition, the fee schedule reduces permit renewal fees for positive uses of the right-of-way and increases some private-use occupation fees. Lastly, the fee schedule institutes a street vacation filing fee to replace the fees in SMC 15.04.074 to advance the goal of full cost recovery for permitting. The proposed fee update is in alignment with SMC 15.04.074 to advance the goal of full cost recovery for permitting.

This legislation advances the goal of full cost recovery for permitting activities, reducing the need for use and occupation fee subsidy for permit review, coordination, and inspection. In addition, this legislation frees use and occupation fees to be returned to the community in the form of investments to support managing right-of-way, activating public space, and leveraging development and utility restoration efforts. These improvements to the right-of-way return the value of using the right-of-way to the community that experienced disruption.
