Budget Action description:

This green sheet appropriates \$423,673 in General Fund (GF) support in 2019 and \$666,411 in 2020 to the Human Services Department (HSD) to increase the inflationary adjustment provided to HSD contract supported by the GF to 2.6 percent, which is the projected CPI-W for Seattle. The increase is in addition to the \$1.7 million in 2019 and \$3.6 million in 2020 provided as an inflationary adjustment for GF supported contracts in the 2019 Proposed Budget. In providing these funds to contractees, HSD is instructed to prioritize wages and benefits for 1) workers with the lowest wages and 2) positions that have the highest turnover and vacancy rates within the contracted organization.

This green sheet requests a report from HSD discussing how these funds were used for any contract over \$40,000. The report should be submitted to the Council's Housing, Health, Energy, and Worker's Rights Committee and the Central Staff Director by September 15, 2019.
