## **1. BILL SUMMARY**

- a. Legislation Title: AN ORDINANCE relating to Seattle Public Utilities; declaring certain real property rights relating to sewer and storm drain easements within Seattle as being surplus to City utility needs; authorizing the Director of Seattle Public Utilities to relinquish such easement rights and to accept new easements; placing the real property rights and interests conveyed by the easements under the jurisdiction of Seattle Public Utilities; and ratifying and confirming certain prior acts.
- **b.** Summary and background of the Legislation: This ordinance would authorize the City of Seattle to relinquish five utility easements and to accept five utility easements. The relinquished utility easements are no longer necessary, and the property owners asked the City to relinquish the easements.
