### 1. BILL SUMMARY

# **Legislation Title:**

AN ORDINANCE relating to land use and zoning; granting conditional approval of the University of Washington 2018 Seattle Campus Master Plan; and amending Chapter 23.32 of the Seattle Municipal Code (SMC) at pages 61, 62, 63, 77, 78, 79, 80, and 81 of the Official Land Use Map.

## **Summary and background of the Legislation:**

This bill grants conditional approval of the University of Washington 2018 Seattle Campus Master Plan (CMP) (Clerk File 314346) and approves changes to the Major Institution Overlay's height limits.

The University of Washington proposed a new CMP to allow the development of up to six million square feet of new development on campus over the next ten years. After receiving comments from the City/University Community Advisory Committee, the Seattle Department of Construction and Inspections, the Seattle Hearing Examiner and over 35 Parties of Record, the Council adopted Resolution 31839, its preliminary decision on the CMP. This bill would grant final conditional approval of the Campus Master Plan.

Key conditions of approval include:

- Requiring construction of 450 units of affordable housing over the life of the plan;
- Lowering the maximum permitted height of development at the northwest corner of 11<sup>th</sup> Avenue NE and NE Campus Parkway;
- Applying a cap of 9,000 parking spaces on campus, including parking accessory to student housing;
- Setting a goal that by 2028 no more than 12% of trips to the Campus be made by individuals travelling alone; and
- Requiring support for a number of transit improvements.
