

This was a 7-member committee appointed by Boulder City Council. We worked with city and county staff, engineering and public process consultants and developed a Transportation Master Plan for the Boulder Valley; a multi-model transportation master plan adopted by City Council and still in use today. As the most frequent transit user I advocated for planning and implementation of the transit component. I also co-chaired dozens of public outreach meetings throughout the community.

* Boulder Citizens Transportation Advisory Committee (1988-1993) (Chair; 1991-1993)

This was the next iteration in the transportation planning and implementation process. This committee was also appointed by Boulder City Council. I worked extensively on employer and school/university based transit pass programs. I negotiated with the Denver Regional Transit District (RTD) for these programs and for increased transit service within Boulder and between Boulder/Denver and surrounding communities. I chaired twice monthly meetings and public outreach events for 2 years. I collaborated extensively with Go Boulder, a newly formed division of the City of Boulder Transportation Department tasked with promoting alternative modes of transportation; a very new concept at the time.
