1. BILL SUMMARY

Legislation Title: A RESOLUTION supporting the Seattle Public Schools’ Proposition 1 and Proposition 2 and urging Seattle voters to vote “Yes” on Proposition 1 and Proposition 2 on the February 12, 2019, special election ballot.

Summary and background of the Legislation:

Propositions 1 and 2 complement the City of Seattle’s Families, Education, Preschool, and Promise Levy (FEPP Levy) (Ordinance 125604 and Resolution 31821), which was approved by voters in the November 2018 general election and because the City of Seattle recognizes that an ongoing partnership with SPS and its Board of Directors is an important partnership that yields meaningful investments in the children and young adults enrolled at SPS, Seattle City Council urges Seattle voters to vote “Yes” on Seattle Public Schools’ Proposition 1 and Proposition 2 in the February 12, 2019, special election.
