Revisions being considered include clarifying and substantive language, including language related to disruptions at committee meetings and the failure of individuals to follow the presiding officer's or security official's instruction.

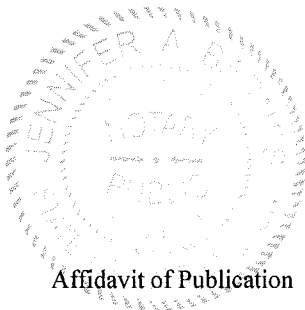
