## **1. BILL SUMMARY**

1. Legislation Title: AN ORDINANCE relating to the 2018 Families, Education, Preschool, and Promise Levy; approving an implementation and evaluation plan as required by Ordinance 125604; amending Ordinance 125724, which adopted the 2019 Budget; changing appropriations to the Department of Education and Early Learning and budget control levels, and from various funds in the Budget; and ratifying and confirming certain prior acts; all by a 3/4 vote of the City Council.

## 2. Summary and background of the Legislation:

This legislation approves a Families, Education, Preschool and Promise Levy Implementation and Evaluation Plan ("the Plan") as required by Section 7 of Ordinance 125604. Ordinance 125604, which authorized a \$619.6 million, seven-year education services levy package, directs that Levy proceeds can only be invested in with a Plan approved by ordinance. The Plan sets out the priority criteria, measurable outcomes, and methodology by which Levy proceeds-funded strategies will be selected and evaluated. The Plan includes the process and schedule by which partners will be selected to provide services as well as the evaluation methodology to measure individual investment and overall Levy impacts. The Plan also includes a summary of outreach and engagement activities conducted that was used to inform the development of the Plan and its content.

A ratify and confirm clause approving actions prior to the ordinance effective date is included because it has been necessary to start certain activities in early 2019 in order to ensure continuity of services and minimize service disruptions. Additionally, it was necessary for the Department of Education and Early Learning to begin the Request for Qualifications (RFQ), Requests for Investments (RFI), contract negotiations, and SPP enrollment in early 2019 with certain service providers in order to secure timely services for the 2019-2020 school year.

The legislation also amends the Adopted Budget in Early Learning in order to recognize appropriation changes necessary to carry of the Plan. The Early Learning budget is amended to reflect changes in the department's budget to account for revenue collected through Seattle Preschool Program tuition. The budget originally assumed a voucher model, whereby DEEL would no longer collect tuition directly from families; however, through the planning process, the department has decided to continue collecting tuition on behalf of all SPP providers. The department anticipates that collected tuition will total \$2.2 million for the 2019-2020 school year based on policy changes and historical

collection rates, with \$860,000 collected in 2019. This change in appropriation authority will be fully backed by tuition revenue.

The Plan outlines DEEL's commitment to achieving educational equity through the four primary investment areas: Preschool and Early Learning, K-12 School and Community-Based, K-12 School Health, and the Seattle Promise. The overarching goal of the FEPP Levy is to "achieve educational equity, close opportunity gaps, and build a better economic future for Seattle students." In order to do so, DEEL identified three core strategies: equitable educational opportunities, high-quality learning environments, and student and family supports. More information about the core strategies and the RSJI implications of DEEL's evaluation methodology can be found in the Plan.

Additionally, DEEL demonstrates alignment to the RSJI through the utilization of Racial Equity Toolkits (RET), commitment to the Our Best Initiative, and the FEPP Levy's commitment to educational justice. DEEL commits to apply RETs toward FEPP Levy budgetary, programmatic, and policy decisions in order to minimize harm and maximize benefits to Seattle's communities of color. In partnership with DEEL's RSJI Change Team, DEEL will present at least four RETs pertaining to FEPP investments to City Council as part of the department's annual Change Team presentation.
