## **Conservation Futures Tax Funding**


The Conservation Futures Tax Program (CFT) is a countywide property tax levy (allowed by state statute) that generates revenue to protect forests, farms, outdoor recreational areas, and open space. Since 1990, CFT has been the major source of matching funds for the City's acquisition programs, including:

- King County Open Space and Trails Bond program
- 2000 Pro Parks Levy
- 2008 Parks and Green Spaces Levy
- Seattle Park District

### What have we used it for so far:

- ~150 properties and ~130 acres acquired
- ~\$63 million in CFT awards used to match City funds

## **Conservation Futures Interlocal**

### What is the CFT Interlocal?

- The CFT Interlocal is the agreement between King County and the City regarding CFT awards to the City.
- Each time the King County Council approves a CFT award to a city, the county-city CFT Interlocal Agreement needs amendment before CFT awards may be reimbursed for acquisition projects.
- In the past, the City Council and County Council have needed to approve this amendment via legislation. The County Council recently removed this step from their process since CFT awards are already approved during the budget process.

#### Why are we changing the Interlocal?


- Streamline and shorten the process to get reimbursements faster
- Reduce duplicative legislation via the City Council (the Council already appropriates acquisition funding and approves individual acquisitions)
